# Scenario # 1 Testifying before your own Commission

- You are the chair of your Planning Commission
- One of the members tells you as the Chair that she will step down for the next hearing because she is an abutter
- She tells you that she will testify as an abutter and remain in the audience
- She will not return to the Commission to discuss and vote on the case
- What do you do?

### Scenario # 1 Possible Responses

- A. Say nothing and start the public hearing
- B. Call a recess to check the Commission regulations and rules of procedure to see how to proceed
- C. The subject of the hearing is a minor issue and you decide this will have no impact on financial interest and property values. Move ahead with the hearing
- D. Ask the commissioner if she has talked to the city attorney about the situation. If she hasn't, ask her to leave the room
- E. Other?

# "Ethical" Situations Facing Public Officials

- Conflict of interest real or perceived
- Day job versus commissioner role
- Relatives involved with application
- Ex parte communications
- Electronic media use
- "Avoiding" difficult vote
- Decisions without findings
- Decisions that are made too soon/take too long/too little information
- Your neighbors are applicants
- Bias issues
- Political pressure from above
- Conflict between Comprehensive plan and zoning ordinance
- Public officials' "public" demeanor
- How to be "fair" in seemingly unfair situations
- Too "friendly" with applicant at meeting

# Open, Ethical & Transparent Meetings & Decision Making

#### In general:

- Decision making is impartial and timely
- Meetings and decision are based on clear rules that are followed
- Decisions are based on the law (state & local) & the Plan (if applicable)
- Decisions are based on findings of fact—build a record
- "Own" the decision it is the Commission's decision, not the applicant's or audiences'
- Meetings are free from conflict of interest
- Proceedings inspire public confidence
- The public is genuinely invited to participate
- Information is available to all

- ✓ Response to recurring problem or one time problem.
- ✓ Lack of other state or local code for guidance

- ✓ City/county charter
- ✓ Adopted by public body/citizens/other?

#### What to adopt –

- ✓ If state does/does not have applicable ethics code.
- ✓ Aspirational versus regulatory
- ✓ Topics to include:

# Chatham County-Savannah MPC Statement of Ethical Principles in Planning

#### Two Overarching Principles

- Planning process must pursue & serve the public interest (Seven underlying principles)
- Planning Process must strive to achieve high standards of integrity & proficiency so that public respect is maintained (Twelve underlying principles)

### Chatham County-Savannah MPC Planning Commissioners Creed

- Place competence & effectiveness of service to the public above other interests
- Represent the best interests of the community as a whole
- Assimilate all information prior to committing to a decision
- Prepare myself for all items before the Commission
- Make services equally available to any citizen
- Abstain from participation when I have a conflict of interest
- Avoid unilateral action that does not comply with the Commission policy
- Work with staff & others to achieve the most desired results
- Refuse personal gifts where I believe the gift is based on my official position, the giver's interest could be affected by my official decision or it may reasonably be considered to be designed to influence my official actions

### California Fair Political Practices Commission

#### Local Agency Ethics Training - Core Topics

- Laws relating to personal financial gain (conflict of interest laws, bribes)
- Laws relating to claiming prerequisites of office (gifts, honoraria, misuse of public funds)
- Government transparency laws (Economic interest disclosure, Brown Act, Public Records Act)
- Laws relating to fair processes (common law bias prohibition, due process, nepotism)

### Los Angeles City Ethics Commission

"Helps to preserve the public trust by promoting elections and government decisions that are fair, transparent and accountable..."

- Administers & enforces Governmental Ethics ordinance
- Implements City laws regarding ethics, campaign finance & lobbying
- Reviews & makes recommendations on policies and regulations and legislation regarding ethics
- Regulations regarding financial disclosure, gifts, outside income, post-city employment, misuse of position, political activities etc.
- Provides advice informal & formal to city officials & employees
- Provides education & ethics training (required every 2 years)
- Provides information & resources (Ethics Handbook)
- Whistleblower hotline

#### Massachusetts Ethics Commission

#### Provides:

- Training resources workshops, on-line PowerPoints, ethics law summaries, FAQs
- Advisory opinions upon request
- Information on how to file ethics complaints
- Ethical Commission rulings (names & fine \$ amount)
- Chapter 28 of the Acts of 2009 Ethics Reform law requires mandatory on-line training and test every two years for all state, county and local public employees (this includes elected/appointed officials)

# Scenario #2 Conflict of Interest - Family

- A) Is it a conflict of interest for a commission member to vote on an application for a grocery store to be located in proximity to where his parents live?
- B) Is it a conflict of interest for a commission member to vote on an affordable housing development application when her sister is an abutter to the site of the development?

## Scenario #2 Conflict of Interest - Family

- A) No The court found no prohibited conflict of interest because there was no evidence that the board member did his parent's grocery shopping or that the parents would shop at this particular store (N.J. Superior Court)
- B) Yes A board member is prohibited from participating in a particular manner in which she has knowledge that an immediate family member has a financial interest. Under the conflict of interest law, an abutter is presumed to have a financial interest in matters on abutting property. Mass. Ethics Commission (Board member fined \$2000)
